

Terms and Conditions for SDSA Digital Raffle 2021

1. These terms and conditions ("Terms and Conditions") shall apply to the "Singapore Disability Sports Awards Digital Raffle 2021" ("Donation Draw") organised by the Singapore Disability Sports Council ("SDSC").

2. By registering or taking part in this Donation Draw, you agree to be bound by these Donation Draw Terms and Conditions and the decisions of SDSC and its associated partners, in relation to and in connection with this Donation Draw.

Qualifying Period

3. The sale of Donation Draw tickets will be conducted online, from 1200 hrs, Thursday, 1 July 2021 to 2359 hrs, Thursday, 29 July 2021 (both dates inclusive) ("Donation Draw Period").

Eligibility

4. You must be 12 years and above (as of the start of the Donation Draw Period) and be a Singapore citizen, Singapore permanent resident or Singapore resident (with a valid employment pass or work permit) to participate in the Donation Draw ("Participant(s)"). Participants aged below 18 years old must be accompanied by a parent or guardian if he/she is a Winner.

5. Participants are invited to fill in a Google Form, <u>bit.ly/SDSADigitalRaffle2021Form</u>, to indicate the number of Donation Draw tickets they intend to purchase, before making payment for the tickets via SDSC's giving.sg page. With every one (1) Donation Draw ticket purchased, each Participant is eligible for one (1) chance to enter the Donation Draw to stand a chance to win the prizes available.

6. Participants shall receive, via e-mail sent by <u>corpcomm@sdsc.org.sg</u>, a confirmation of the number of tickets purchased, and their accompanying serial number.

7. All permanent and/or contract employees ("Employees") of SDSC and their immediate family members (i.e. spouses, children, parents, brothers and sisters) ("Immediate Family Members") are ineligible to participate in the donation draw. Members of the SDSC community, for example, athletes, coaches, technical officials and volunteers are welcome to participate.

8. SDSC has the absolute discretion to determine the eligibility of all Participants. Such determination shall be final and conclusive and SDSC is not obliged to give any reason for its determination.

Prize

9. There will be twelve (11) prizes in total and a total of thirty (30) winners in total. The winners for the Donation Draw ("Winners") will be drawn at random and announced at 2000hrs on Thursday, 5 August 2021 ("Draw Date") at the Singapore Disability Sports Awards virtual event.

10. Prizes are kindly donated by supporting partners of the Donation Draw. Prizes are nonrefundable. Prizes are subject to Terms and Conditions by the partners and these will be communicated to the Winners upon redemption of prizes.

11. All Winners shall be notified by phone at their phone number or via e-mail sent by <u>corpcomm@sdsc.org.sg</u> within seven (7) calendar days of the Draw Date, with instructions of redemption of their prize.



12. Prizes that are not redeemed within thirty (30) calendar days from the Draw Date will be forfeited and donated to SDSC. No correspondence or claims will be entertained in the event of such forfeiture. A Participant whose prize has been forfeited shall not be entitled to any payment or compensation whatsoever from SDSC.

13. Reserve winner(s) will be drawn to replace any winner(s) subsequently disqualified.

14. If SDSC discovers that a Winner was not entitled to participate or if a Winner is subsequently disqualified from participating in the Donation Draw, SDSC may at its discretion forfeit the Prize, reclaim it after award and then choose an eventual winner from the reserve winner list or donate it to SDSC.

15. Prizes are not transferable, or exchangeable for cash, credits or any other item or otherwise, either partially or wholly. Use of the Prizes shall be subject to SDSC's terms and conditions.

16. The Donation Draw is held on a standalone basis and not incidental to any broader fundraising event. The purchase of Donation Draw tickets by Participants is considered an outright sale and is regarded as payments made in return for the chance to participate and win prizes in the Donation draws. As they are not pure donations, no tax deduction will be allowed on any amount donated.

Use of Personal Information

17. By participating in the Donation Draw, the Participants (including the Winners) are deemed to have consented to:

i) the collection, use and disclosure of his/her name, identification/passport number, image, voice and/or likeness by SDSC and its associated partners for editorial, advertising, promotional, marketing and/or other purposes without any payment and/or compensation except where prohibited by law; and

ii) receiving promotional, marketing and other publicity information from SDSC from time to time.

General

18. The decisions of SDSC on all matters relating to or in connection with the Donation Draw are final, conclusive and binding. SDSC shall not be obliged to give any reason or enter any correspondence with any person on any matter concerning the Donation Draw.

19. SDSC reserves the right at any time in its sole and absolute discretion to determine and/or amend or vary these terms and conditions without prior notice, including but not limited to cancelling, extend, terminating or suspending this Donation Draw, the eligibility terms and criteria, the selection and number of winners, and the timing of any act to be done, and all Participants shall be bound by these amendments.

20. SDSC shall not be responsible for any injury, loss or damage suffered as a result of, or in connection with the Donation Draw and/or redemption or use of the Prizes howsoever arising, including but not limited to, fulfillment of the prize(s), any error in computing chances, any breakdown or malfunction in any computer system or equipment, any notice which is misdirected and/or lost in the post, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties howsoever arising whether in contract, tort, negligence or otherwise. For the avoidance of doubt, cancellation, termination or suspension by SDSC of this Donation Draw shall not entitle any party to any claim or compensation against SDSC for any and all losses



or damage suffered or incurred as a direct or indirect result of the act of cancellation, termination or suspension.

21. In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Donation Draw, these Terms and Conditions shall prevail.

22. The Donation Draw and these Terms and Conditions shall be governed by the laws of the Republic of Singapore and all Participants (including the Winners) are deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.

23. A person who is not a party to any agreement governed by these terms and conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any terms of such agreement.
