#### Hear it from our beneficiary - Yip Pin Xiu, 30, Charcot Marie Tooth disease

My life has changed through sport.

There are many families who do not dare to let children do things as they wish, more so when they are disabled. Luckily, mine was different. When I was 5, I was granted my wish to learn swimming with my brothers, after a long while sitting poolside with my leg braces, watching them. It was then that I realised: in the water, I could still walk.

Everytime I make it to the podium, I feel a surge of gratitude for my family and my supporters who have given me the confidence and opportunities to enjoy sport. Sadly, many other disabled persons are still not able to benefit from sport, the way I have. I am therefore hoping that you will consider playing a part to help them transform their lives.

The Singapore Disability Sports Council (SDSC) has been a pillar of my journey. Not only have I been able to train and compete well because of their coaches, volunteers, donors and partners over the years, I was able to map my path with their help, leading to my success through sport. Today, the SDSC continues to play a critical role in my programme, while it also works to help other disabled persons find their 'success' through sport. Some, like me, are exhilarated by breakthroughs through performance. Others relish the social networks they build through sport, and better physical and mental functions.

This is why I decided to step up to the board of SDSC, to give back and help more people. There are many more disabled persons who can live better through sport, if you are willing to lend your support or voice.

I hope that you will share my story and the work of SDSC to others you might influence. As Mother Teresa said, "I alone can't change the world, but I can cast a stone across the water to create many ripples."
