

COURSE FOR NATIONAL CLASSIFIERS FOR ATHLETES WITH VISUAL IMPAIRMENT

The Portuguese Sports Federation for People with Disabilities (FPDD) and the Paralympic Committee of Portugal (CPP), we will organize, on 12 and 13 November a **Course for National Classifiers for Athletes with Visual Impairment**. The course validated and has the agreement of IBSA.

This course takes place **just before** the World Judo Championship, an IBSA event, held in Portugal, Lisbon / Odivelas on November from 13 to 18 November, and organized by the Portuguese Judo Federation (FPJ).

Course leaders are IBSA / IPC International Classifiers.

The course is open for **ophthalmologists** and other health professionals related with vision, namely **orthoptists and optometrists**, from all countries members of IBSA. It aims to enable the national classifiers with the necessary knowledge for a proper visual classification of the athletes competing in all the sports adapted to the visual impaired.

The objectives of Course are: to give information regarding visual parameters and boundaries required, for an athlete to participate, in international championships; to achieve a proper national classification of the visual impaired athletes; to provide the essentials for the process and procedures, when an international classification is required, namely the correct way to fill the Medical Forms, avoiding unnecessary costs and frustrations, with potentially ineligible athletes, who travel to international competitions.

The course will take place in Olaias Park Hotel, the 12 and 13 November 2018, and is limited to 15 participants (*minimum 5*), with priority for the pre-registration date and a proposal by a National Sport Federation.

The course will be conducted, with theoretical and practical components in English.

The participants support the all the costs with traveling, accommodation and meals.
